25 Year System Limited Warranty**

**LIMITED WARRANTY**

H.B. Fuller Construction Products Inc. ("HBF-CP") warrants, subject to the terms, conditions, limitations, and disclaimers herein, that the system<sup>1</sup> ("System"), for the period<sup>2</sup> described below, will:

- reduce the moisture vapor emissions of LiquiDam™ or LiquiDam EZ™ treated concrete substrate from a maximum of 25 pounds per 1000 sq. ft./24 hours as determined by the Calcium Chloride Test Method ASTM F1869 (or 100% RH using the Relative Humidity Method ASTM F2170) to no more than 3 pounds per 1000 sq. ft./24 hours
- if moisture vapor emissions comply with above, and the TEC® and Parabond® products listed in the table below are used as a complete System, the System a) will not fail due to a manufacturing defect, b) will prevent flooring damage and bond failure caused by vapor emissions from the concrete substrate.

provided that the Products comprising the System are properly applied within their applicable shelf life and in accordance with HBF-CP's written guidelines, Product Data Sheets and Specifications found at [tecspecialty.com](http://tecspecialty.com) in effect on the date of its application and consistent with all applicable building codes and industry standards and guidelines, including the TCNA Handbook when applicable, and procedures for professional application to the extent they are consistent with HBF-CP's written guidelines and specifications. This is the sole and exclusive warranty for the products below when they are installed as a System.

**EXCLUSIVE REMEDIES**

**HBF-CP's and Seller's sole and exclusive liability, and the sole and exclusive remedy for any loss or damage arising from the purchase or use of the Products when installed as a System shall be to supply the claimant with labor and materials necessary to repair or replace, merely one time, the portion of the installation which HBF-CP has determined needs repair or replacement. HBF-CP may remedy grout cracking resulting from repetitive dynamic substrate cracking or movement with a sealant in lieu of grout and the foregoing warranty does not cover such sealant.**

The duration of the warranty on any replacement Product(s) will not exceed the balance of the warranty remaining on the Product that was replaced as of the date of such replacement.

**WARRANTY CLAIM PROCEDURE**

In order to qualify for the remedies described above, the claimant must notify HBF-CP, in writing, within thirty (30) days of discovering the allegedly defective condition. Claimant must provide proof of purchase of the Product which is alleged to be defective and covered by the foregoing warranty. Claimant must provide HBF-CP a

reasonable opportunity to review and investigate the alleged defect. Claimant must send, e-mail or fax written claims to:

of God, (viii) subfloor moisture (except in the case of moisture control products LiquiDam Penetrating Moisture Vapor Barrier or LiquiDam EZ Moisture Vapor Barrier) or water damage, substrate failures caused by Alkali Silica Reaction (ASR) or Near Surface Alkali Reaction (NSAR), (ix) any surface not installed in accordance with the manufacturer's recommendations including, but not limited to, temperature, relative humidity, and proper maintenance or (x) any surface not installed in accordance with the manufacturer's most recent published literature pertaining to glue down installations, including, but not limited to, wood flooring acclimation, expansion space, jobsite temperature, relative humidity and air flow requirements.
