You further acknowledge and agree that the price of the specified Product or System reflects all the terms of the Limited Warranty, including the Disclaimer of Warranties, Limitation of Liability, and Limitation of Remedies, and that without their inclusion, in whole or in part, the price of the specified Product or System would be substantially higher. Parabond® Flooring Adhesive System Limited Warranty

Subject to the terms, conditions, limitations and disclaimers herein, if You provide TEC Specialty Products LLC ("TEC Specialty") notice of (1) a substantial manufacturing defect or (2) breakdown or deterioration under normal use TEC Specialty will, at its sole option and expense, for each warranty claim that it determines to be valid, supply the Owner with labor and materials necessary to repair or replace, merely one time, the portion of the installation which TEC Specialty has determined needs repair or replacement due to the defective Product or System, or replace or refund the amount Owner paid for the defective Product or System. TEC Specialty may remedy grout cracking resulting from repetitive dynamic substrate cracking or movement with a sealant in lieu of grout and the foregoing warranty does not cover such sealant.

The duration of the warranty on any replacement Product and/or System will not exceed the balance of the warranty period remaining on the Product and/or System that was replaced as of the date of such replacement.

TEC Specialty reserves the right to determine a suitable substitute at its sole option in the event the tile, stone or any finish material used in the original installation is no longer readily available.

Requirements / Prerequisites

For the Limited Warranty Coverage to apply, the Product/System must be properly applied within its applicable shelf life and in accordance with TEC Specialty's written guidelines, Product Data Sheets and Specifications found at www.tecspecialty.com in effect on the date of its application and consistent with all applicable building codes, industry standards, guidelines and procedures for professional application to the extent they are consistent with TEC Specialty's written guidelines and specifications. **TEC Specialty is not responsible for any loss or damage resulting from the use of the Product/System inconsistent with the requirements identified in this paragraph, and the Owner waives any claims against TEC Specialty if these requirements are not met.**

WARRANTY CLAIM PROCEDURE

In order to qualify for the warranty benefits described in the Coverage section above, the Owner must:

- 1) Notify TEC Specialty, in writing, within 30 days of discovering the alleged defect and before the expiration of the warranty period and provide proof of purchase of the allegedly defective Product and/or System. Owner must provide TEC Specialty the lot numbers and a reasonable opportunity to review and investigate the alleged defect; and
- 2) Upon request by TEC Specialty, provide TEC Specialty or an independent third party engaged by TEC Specialty with access to the application site in order to allow TEC Specialty or an independent third party to physically inspect, perform testing, and obtain samples at the application site, before TEC Specialty makes a determination regarding the validity of the claim. Conducting such investigation does not obligate TEC Specialty to take any specific course of action. The Owner agrees to pay for such inspection and all related costs of TEC Specialty in the event the warranty claim is invalid. The Owner acknowledges that the Owner waives any and all claims regarding the Product and/or System in the event the Owner does not provide this access upon request. The Owner also acknowledges that any repairs or demolition of the affected area prior to an inspection and/or investigation by TEC Specialty will void the benefits available under the Limited Warranty stated herein, and waive any and all claims regarding the Product and/or System; and

EXCLUSIONS

The foregoing warranty does not cover damage or other harm from routine maintenance or cleaning, any defects, damage or other harm that is not the result of the acts or omissions of TEC Specialty, or that arise to any extent or in any way from (i) the failure of Owner or Product applicator to follow any applicable instructions of TEC Specialty or other manufacturers, if any, (ii) the abuse, misuse or modification of the Product, (iii) structural failure or workmanship not in accordance with TEC Specialty's instructions and applicable industry standards, (iv) normal wear and tear resulting from usage, (v) installations with improper substrate preparation, sewer backup, acts of God, excessive or low relative humidity or any issues not related to excessive moisture proven to be coming through the moisture vapor barrier, if one was applied, (vi) any surface not installed in accordance with the manufacturer's recommendations including, but not limited to, temperature, relative humidity, and proper maintenance (vii) any surface not installed in accordance with the manufacturer's most recent

published literature pertaining to glue down installations, including, but not limited to, wood flooring acclimation, expansion space, jobsite temperature, relative humidity and air flow requirements; acts of negligence before, during and/or after installation; or (viii) subfloor moisture (except in the case of moisture control products LiquiDam™ Penetrating Moisture Vapor Barrier or LiquiDam™ EZ Moisture Vapor Barrier) or water damage, substrate failures caused by Alkali Silica Reaction (ASR) or Near Surface Alkali Reaction (NSAR).¹
