





# **TEC® HydraFlex™ Single Layer Floor System**Specifications and Guidelines

#### **Appropriate Applications:**

• Residential to light commercial.

#### **Approved Substrates:**

#### **Suitable Subfloors**

- APA Rated IP Sturd-I-Floor™ Exposure 1 or better, Plywood or OSB.
- AdvanTech® OSB flooring panels.
- Exterior grade plywood (APA grade trademarked exterior plywood).
- Underlayment grade plywood, Exposure 1 or better.
- CDX plywood Exposure 1.
- LP® Top Notch® and Top Notch® Orange Plus® OSB tongue and groove flooring.

#### **Subfloor Installation Requirements**

- 23/32" minimum thickness.
- Joist spacing up to and including 16" o.c.
- Must be tongue-and-groove edges (or 2" lumber blocking beneath edge joints in between ioists).
- Install with long dimension across supports and initial 1/8" spacing at end and edge joints.
- Securely fastened to joists with subfloor adhesive and wood screws or 6d ring shank nails 12" o.c. at panel ends and intermediate supports. Without subfloor adhesive, fasten with wood screws or 6d ring shank nails 6" o.c. at panel ends and intermediate supports.
- Maximum deflection of 1/360 of the span when measured under a 300 lb. concentrated load.

#### **Subfloor Surface Preparation:**

#### Clean:

- Sweep first then remove fine dust with vacuum or compressed air. If using compressed air, ensure that compressor oil is not inadvertently sprayed onto the floor. (Do not use a method involving water when cleaning floor)
- Evaluate success of cleaning methods by wiping surface with a black cloth. If dust is still present, repeat cleaning.

#### **Integrity:**

- Do not install over wet subfloor.
- Remove any loose wood strands.
- Fill all holes in subfloor.

#### **Subfloor End and Edge Joints:**

• Place a 12" to 24" straight edge perpendicular to the joints to see if the edges of the subfloor panels have peaked.

- If there are no gaps between the straight edge and the subfloor panels on either side of the
  - joint, proceed with the mesh installation as described below.
- If there is a gap under the straight edge on either side of the joint, the joint must be sanded down.

#### **TEC® Mesh Installation:**

- Trowel, roll or brush a minimum 9" width of HydraFlex™ over all subfloor end and edge joints.
- Immediately place 6" wide TEC® mesh over wet HydraFlex™ and embed by troweling over the mesh.

#### **HydraFlex**<sup>™</sup> **Installation**:

- Apply membrane to entire surface using 1/4" to 1/2" nap roller or 3/16" v-notch trowel.
   Membrane may be applied in one coat.
   Measure membrane periodically with a wet film thickness gage to ensure a minimum thickness of 50 mils wet, curing to a dry film thickness of 30 mils.
- Allow to cure 2 to 3 hours. Cure time is based on 70°F (21°FC) and 50% RH. Thicker films, cooler temperatures or higher humidity will extend cure time.

#### Set Tile:

- Set tile directly to approved subfloor using TEC® TotalFlex® 110 & 150, Super Flex™, Full Flex®, 3N1™, Fast Set 3N1™ or Sturdi Flex™.
- Use appropriate size notched trowel to ensure 100% coverage.
- Allow to cure 12-16 hours before grouting (4 hours for Quik Flex®).

#### Acceptable tile types:

 Ceramic and porcelain tile up to and including 20" x 20".

#### **Unacceptable tile types:**

- Ceramic and porcelain tile greater than 20" x 20".
- Any size natural stone due to Marble Institute of America requirements for 4/20 maximum deflection.

#### LIMITED WARRANTY

- The tile<sup>2</sup> and Power Grout<sup>®</sup> or AccuColor EFX<sup>®</sup> Epoxy Grout and HydraFlex<sup>™</sup> Membrane will not crack.
- The TotalFlex® 110 & 150, Super Flex™, Full Flex®, 3N1™, Fast Set 3N1™ or Sturdi Flex™ Mortar will maintain the bond between tile and approved substrate³.

provided that the Product was properly applied as a System within its applicable shelf life and in accordance with TEC Specialty's written guidelines, Product Data Sheets and Specifications found at tecspecialty.com in effect on the date of its application and consistent with all applicable building codes and industry standards and guidelines, including the TCNA Handbook when applicable, and procedures for professional application to the extent they are consistent with TEC Specialty's written guidelines and specifications.

#### **EXCLUSIVE REMEDIES**

TEC Specialty will, at its option and expense, for each warranty claim that it determines to be valid, supply the Owner with labor and materials necessary to repair or replace, merely one time, the portion of the installation which TEC Specialty has determined needs repair or replacement due to defective Products or System, or replace or refund the amount Owner paid for the defective Product or System. TEC Specialty may remedy grout cracking resulting from repetitive dynamic substrate cracking or movement with a sealant in lieu of grout and the foregoing warranty does not cover such sealant

The duration of the warranty on any replacement Product and/or System will not exceed the balance of the warranty remaining on the Product and/or System that was replaced as of the date of such replacement.

#### **WARRANTY CLAIM PROCEDURE**

In order to qualify for the remedies described above, the Owner must notify TEC Specialty, in writing, before the expiration of the warranty period described above and provide proof of purchase of the Product or System which is alleged to be defective, regarding the discovery of the alleged defect in the Product or System covered by the foregoing warranty. Owner must provide TEC Specialty a reasonable opportunity to review and investigate the alleged defect. Owner must send or fax written claims to:
